## School Facebook Page

We have been running our closed school Facebook page for a number of years now. The purpose of it is to communicate with you more effectively and immediately to let you know what is going on in our school. This is in addition to our usual methods of communication (text, newsletter and website) so if you don't use Facebook please do not feel you will receive less information. In order for this to continue to be a positive and effective means of communication we follow strict rules and guidelines for the group.

Our Facebook page operates as a closed group so that only approved members may view the content.

### What we will do:

- Share information about school events
- Celebrate good news
- Send reminders
- Let you know when pupils have arrived/departed safely from school trips
- Delete inappropriate comments

#### What we won't do:

- Use names of children, staff or parents unless it is to congratulate or thank
- Allow anyone who is not the primary carer of a child, a governor or member of staff in our school

- Include any photographs or videos of children where parents have requested they do not appear on the page

# What you can do:

- Join our group whilst you have children in our school
- Ask questions about non-uniform days, school trips, school events, homework etc
- Post comments although these will need to be approved by the group admin before the appear
- 'Like' comments from other members of the group
- Answer each other's questions if you are able to

#### What you cannot do:

- Remain in the group once your child has left our school
- Post complaints, criticisms or anything that might cause offence to any member of the school community
- Name people individually that might cause upset or offence
- Share any photos or videos from our page onto your own social media
- Allow your child access to the page

We do want to hear from you when you are upset, concerned, worried or angry but it is not appropriate to do so in a public forum. As always, in these circumstances, we need to hear from you directly so that we can deal with any problems in accordance with our school complaints procedures.

Please also be aware that the group administrators will not be able to answer any questions posted immediately, especially in school time, so a phone call to the school office will guarantee you a quicker response in an emergency.

Facebook is open to misuse so we need to be very clear that anyone who does not follow the guidelines will be removed from the group and may not be allowed to re-join.
